IFDM 2024 is the 11th International Biennial Congress focused on Disability Management and Return to Work. Held biennially since 2002, the IFDMs have been held in Vancouver in 2002, the Netherlands in 2004, Australia in 2006, Germany in 2008, the U.S. in 2010, the UK in 2012, Australasia in 2014, Malaysia in 2016, Canada in 2018, Belgium in 2022 (delayed due to COVID). And now it comes back to Vancouver for 2024.

The IFDMs have brought together leaders as well as practitioners and stakeholder representatives in disability management and return to work from around the world. They have provided the opportunity to bring forward emerging issues, creative solutions, and latest research.
